ORDER

Er. Mahesh Sirkek, Chief Engineer (Comml.) of the respondent Board informs the Commission that the Letter of Intent for the works, "Survey, Design, Supply, Erection/ Installation Testing and Commissioning for construction of 33/11 kV 2x3.15 MVA unmanned sub-station at Dharampur (Gandhigram) falling under Electrical Sub Division HPSEB Ltd. Dharampur, District Solan (HP) on turnkey basis, has been issued on 29.08.2015 to M/s T.S. Power Co, Soki Apartments, D- Sector, Naharalagun

Distt. Papumpare, Arunachal Pradesh. The Tender has been accepted for Rs.3,07,08,827/- i.e. Rs. 1,50,52,337/- for the Supply Part and Rs. 1,58,56,490/- for the Erection Part. All the terms and conditions are to be as per Tender/Bid Document issued in March, 2015. The formal Contract Agreement is yet to be executed and appropriate steps are being taken therefore. He further states that as per directions of this Commission, PERT Chart is also under preparation, which shall be an integral part of the contract agreement. He is hopeful that the whole process of and formalities for awarding the works and execution of the contract shall be completed in the near future and efforts will be made to complete and erect the said sub-station within a year. Sh. P.N. Bhardwaj, the petitioner has expressed his satisfaction in relation to the steps being taken by the Board and is also hopeful that the sub-station shall be commissioned within the time lines informed by the CE (Comml.). Further that the Board and its authorities will continue their appreciable efforts to resolve the public grievance concerning, the erected and poor quality power supply in the Dharampur area and the Board shall maintain continuity and quality of Power Supply as per the prescribed norms not only in the Dharampur area, but also in the entire area of Supply of the respondent Board.

Keeping in view the above submissions made and undertaking given on behalf of the Respondent Board and the satisfaction of the petitioner, the Commission concludes the proceedings in this case.

The petition is disposed of accordingly.
