Desirable Qualification(s)	Knowledge of customs, manner and dialects of Himachal Pradesh and suitability of appointment in the peculiar conditions prevailing in Himachal Pradesh.
Age	Between 18 years and 45 years (as on 01.01.2020).
Eligibility for recruitment	A candidate shall be eligible for appointment, if he/she has passed Matriculation and Middle from any school/institution situated within HP: Provided this condition shall not apply to Bonafide Himachalis.
