Subject: Petition No. 28/2021 i.e. Determination of Average Pooled Power Purchase Cost (APPC) for the financial year 2021-22.

The Himachal Pradesh State Electricity Board Limited (HPSEBL) has filed petition bearing No. 28/2021 before Himachal Pradesh Electricity Regulatory Commission (HPERC) for approval of APPC rate for FY 2021-22.

The HPERC hereby invites suggestions and objections in the aforementioned matter i.e. petition No. 28/2021 from the stakeholders/interested parties before approving the rate of Pooled Cost of Power Purchase for the FY 2021-22 and other issues together with details and copies of documents, if any in support of their suggestions/objections by **25th August, 2021** addressed to the Chief Engineer (Comm.), HPSEBL, Vidyut Bhawan, Shimla-171004 alongwith copy of the same to the Secretary, HP Electricity Regulatory Commission, Vidyut Aayog Bhawan, Block-37, SDA Complex, Shimla-171009.

The HPSEBL shall submit replies to the suggestions/objections so received on affidavit with six copies to the HPERC by **3rd September, 2021** one copy of which shall also be sent to the individual objectors in the form of hard copy as well as through email. The objectors shall submit rejoinder, if any, to the Commission with a copy to the HPSEBL by **13th September, 2021**.

A public hearing in the matter shall be held on **14th September, 2021** at **11.30 AM** onwards through video conferencing.
