### PUBLIC NOTICE INVITING SUGGESTIONS/OBJECTIONS

#### Petition No. 21 of 2018

M/s Himachal Baspa Power Company Limited (hereinafter referred to as the “M/s HBPCCL”) has submitted to the Commission the petition for True-up of FY2014-15, FY2016-17 & FY2016-17 and Mid Term Review for FY2017-18 & FY2018-19 for sale of Power from Baspa II HEP to HPSEB Limited for the Third Control Period (FY15-19) under Section 62, 64 and 86 of Electricity Act, 2003 on 29<sup>th</sup> December, 2017. The salient features of the petition were published by M/s HBPCCL in the newspapers i.e. “Divya Himachal” on 25.05.2018, “The Tribune” and “Dainik Bhaskar” on 26.05.2018 and again in “The Tribune” on 27.05.2018.

As required under Section 64(3) of the Electricity Act, 2003, the HPERC hereby invites suggestions and objections in the matter from the interested parties. Suggestions/objections on the issues together with relevant data, details and copies of documents, if any, in support of the suggestions/objections, be sent to the **Secretary, Himachal Pradesh Electricity Regulatory Commission, Vidyut Aayog Bhawan, Block No. 37, SDA Complex, Kasumpti, Shimla-171009 along with proof of service of the same to M/s Himachal Baspa Power Company Limited, Karcham Wangtoo H.E. Project, Sholtu Colony, P.O. Tapri, Distt. Kinnaur(H.P.)- 172104 by 15<sup>th</sup> June, 2018.**

The suggestions / objections shall be filed in English or Hindi. Suggestions / objections filed in any other language shall not be accepted unless accompanied by authenticated translation in English. The suggestions/objections should be filed in nine copies and should carry the full name, postal address with pin code number, fax number and email address, if any, of the person sending the suggestions/objections. Alternatively the suggestions/ objections can also be filed through email to the Commission ([hperc@rediffmail.com](mailto:hperc@rediffmail.com)) and M/s HBPCCL ([agarwal.anurag@jsw.in](mailto:agarwal.anurag@jsw.in)) along with 2 hard copies to the Commission. It should be indicated whether the objection is being filed on behalf of any organization or any category of consumers. It should also be stated whether the objector wants to be heard in person by the Commission.

M/s HBPCCL shall submit replies to the suggestions/objections on affidavit with 9 copies to the Commission by 30<sup>th</sup> June, 2018, one copy of which shall also be sent to the individual objectors. The objectors shall submit rejoinder, if any, to the Commission with a copy to the petitioner, HPSEBL by 7<sup>th</sup> July, 2018.

The public hearing in the matter shall be held on 13<sup>th</sup> July, 2018 after 11.30 A.M. onwards in the Commission’s Court Room at Shimla, wherein the Objectors can present their cases in the proposed hearing. Stakeholders in general, may also participate in the hearing.
