Case called, both parties were heard. The Respondents were directed to file their reply on or before 10/06/2022 which they failed to do so. They informed that they have sought information from the ES Division Nalagarh regarding IDC. Since the case was limited to interpretation of 1/3rd amount to be deposited at Consumer Grievance Redressal Forum and not on the applicability or calculations of IDC, they were directed to file their reply limited to the current case.

The representative for the Complainant submitted additional information wherein he attached a copy of the final orders passed by the Forum after the orders passed by this court on 27/05/2022 to hold the proceedings. He informed that despite direction to the Consumer Grievance Redressal Forum to hold the proceedings at their end till the disposal of the current case, the Forum passed a judicial order after the said order which is in nullity and without jurisdiction. He further submitted that there are no parallel proceedings for the similar case.

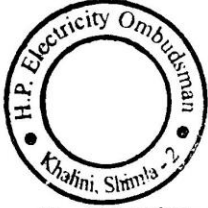
