**Interim Order**

M/S Pawan Sons Enterprises, Plot No. 6, Industrial Area, Parwanoo, District Solan, HP-173220 has filed an application, received & registered on 04/08/2022, under provisions of Regulation 28 (1) (b) of Himachal Pradesh Electricity Regulatory Commission (Consumer Grievances Redressal Forum and Ombudsman) Regulations, 2013 against the Interim Orders passed by the Consumer Grievance Redressal Forum (CGRF) on dated 28/06/2022 in Complaint No. 1421/1/22/08, dated 02/03/2022. Copy of the Complaint has also been sent by post on 04/08/2022 to the Respondents.

The Complainant have also filed an application under provisions of Regulation 36 of Himachal Pradesh Electricity Regulatory Commission (Consumer Grievances Redressal Forum and Ombudsman) Regulations, 2013 with prayer to seek interim relief for restraining the Respondents from demanding outstanding electricity dues of the previous Consumer during the pendency of the current representation and also order to release the electricity connection to them.

Prayer granted. The Respondent Board is restrained from demanding outstanding electricity dues of the previous Consumer during the pendency of the current representation. The Respondent Board is further directed to release the electricity connection to the Complainant after completing of all other codal formalities.

The Respondents are further directed to file their reply **on affidavit duly attested** on or before 20/08/2022 positively. The Complainant may file his rejoinder on or before 26/08/2022. The case is further listed for admission hearing on 27/08/2022 at 12:00 PM or immediately thereafter.
