**Interim Order**

M/S J. B. Rolling Mills Ltd., Vill Kheri, Trilokpur Road, Kala Amb, The Nahan, Distt Sirmour HP-173030 has filed an application, received & registered on 20/03/2023, under provisions of Regulation 28 (1) (b) of Himachal Pradesh Electricity Regulatory Commission (Consumer Grievances Redressal Forum and Ombudsman) Regulations, 2013 against the final Orders passed by the Consumer Grievance Redressal Forum (CGRF) at Kasumpti on dated 03/03/2023 in Complaint No. 1515/4/22/31, dated 30/11/2022. Copy of the Complaint has also been sent by post on 20/03/2023 to the Respondents.

The Complainant have also filed an application under the provisions of Regulation 36 of Himachal Pradesh Electricity Regulatory Commission (Consumer Grievances Redressal Forum and Ombudsman) Regulations, 2013 with prayer to grant interim ex-party stay order. He has further prayed for granting restrained order for recovering and realizing the balance amount against energy bill dated 12/07/2022 fearing disconnection of electricity connection by the Respondents by taking coercive method for recovery of same.

Prayer granted. By the powers conferred under the provisions of Regulation 36 read with Regulation 33 (2) of Himachal Pradesh Electricity Regulatory Commission (Consumer Grievances Redressal Forum and Ombudsman) Regulations, 2013, the recovery and realization of balance amount against energy bill dated 12/07/2022 is hereby stayed during the pendency of the present Complaint with this Appellate Forum and the Respondents are further directed not to take any coercive action to recover the balance amount against energy bill dated 12/07/2022 such as disconnection of electricity connection of the Complainant's premises.
