Case called, the matter was heard. Both the parties advanced their arguments. During the course of arguments, concerned officers exchanged their views on the instant issue and also handed over the relevant documents during the course of arguments which were taken on record considering the austerity of the same towards final findings. The counsel for complainant denied for taking affidavit as contended in the last hearing on dated 02/09/2023 as he showed satisfaction on confirming from the complainant that the old energy meter along with old CT/PT have not been disconnected and are still in the circuit for comparative purpose with reference to the check meter and new CT/PT meters installed.

The arguments could not be finalized as the complainant put forth his submissions for rectification of bill raised by the Respondent Board on account of error apparent to the period of dispute and requested for submission of revised calculations. The Respondent Board accepted the error occurred in computation and this Appellate Forum after going through the record agreed to the arguments made by the counsel for complainant and directed Respondent Board to come along with fresh calculations on the differential bill with due rectification in the next date of hearing. Both Respondent Board and Complainant were further directed to submit written arguments also after the final arguments are heard on the next date of hearing.
