Interim Order

M/S Shree Parvati Steel and Alloys, Village Kheri, Trilokpur Road, Kala Amb, Distt. Sirmour, H.P.173030 have filed an application, received & registered on 19/12/2023, against the final Orders dated 05/12/2023 passed by the Consumer Grievance Redressal Forum at Kasumpti in Complaint No. 1515/2/23/18 & 1515/202308/30. As per record copy of the Complaint has also been sent by post on 16/12/2023 by the Complainant to the Respondents.

The complainant has also filed an Application Under Section 151 of CPC 1908 for Interim direction regarding restraining the Respondent from disconnection of electricity supply to the premises of the Complainant during the pendency of complaint.

Prayer granted. In terms of powers conferred under the provisions of Regulation 36 read with Regulation 33 (2) of Himachal Pradesh Electricity Regulatory Commission (Consumer Grievances Redressal Forum and Ombudsman) Regulations, 2013, the Respondent Board is directed not to take any coercive action towards disconnection of supply during the pendency of the present Complaint with this Appellate Forum.


The Complainant has however not submitted proof of having deposited 50% of the disputed amount with the Respondents as required under the provisions of Regulation 33 (1) (g) of Himachal Pradesh Electricity Regulatory Commission (Consumer Grievances Redressal Forum and Ombudsman) Regulations, 2013. The Complainant is directed to submit the proof of having deposited 50% of the disputed amount with the Respondents immediately. The case shall be admitted only after submission of proof of deposit of 50% of disputed amount and assertion of the maintainability status of the said case on the date of admission hearing.

Accordingly, the case is listed for admission hearing on dated 27/12/2023 at 12:00 PM. or Immediately thereafter.
