Sh. Ved Parkash S/O. Sh. Bhader Ram, Sole Proprietors of Aswan Home Stay. R/O. VPO. Sangla Distt. Kinnaur- 172106 HP. have filed an application, under provisions of Regulation 28 (1) (b) of Himachal Pradesh Electricity Regulatory Commission (Consumer Grievances Redressal Forum and Ombudsman) Regulations, 2013, against the final Order dated 17/01/2024 passed by the Consumer Grievance Redressal Forum at Kasumpti in Complaint No. 1142/202401/02 dt. 16/01/2024. The said Representation was received & registered on 15/02/2024. As per record copy of the Complaint has also been sent by post on 14/02/2024 by the Complainant to the respective Respondents.

In continuation to order dt. 15/02/2024, after scrutiny of the said Application, it was observed that the Complainant has also filed an Application seeking Interim directions regarding restoration of electricity supply to the premises of the Complainant during the pendency of this present complaint, which stands disconnected as per the representation. However, necessary directions in this regard shall be imparted after admission hearing.

The case shall be admitted only after listening to both the parties on the issue of proof of having deposited of 50% of the disputed amount and assertion of the maintainability status of the said case in the court room.

**The case is listed for admission hearing on dated 27/02/2024 at 12:00 PM. or Immediately thereafter which could not be conducted as per schedule on 20/02/2024 as the counsel for Respondent Board conveyed through e-mail dt. 19/02/2024 regarding ill Health of his father and inability to appear in the court on dt. 20/02/2024 in the said matter.**
