**Order**

Case called, the matter was heard on 22/01/2025. The complainant had also filed an Application under Section 151 of CPC,1908 regarding restraining the Respondent from disconnecting the electricity supply to the premises of the Complainant during the pendency of the complaint.


The Complainant has also submitted the proof of having deposited 50% of the disputed amount with the Respondents in the form of receipt dt. 08.01.2025 in the court room in compliance to order dt. 06/01/2025. As per record the Complainant has supplied the copies of representation to all respective respondents.

After listening to both the parties, in terms of powers conferred under the provisions of Regulation 36 read with Regulation 33 (2) of Himachal Pradesh Electricity Regulatory Commission (Consumer Grievances Redressal Forum and Ombudsman) Regulations, 2013, the prayer granted and the Respondents were directed not to take any coercive action such as disconnection of electricity connection of the Complainant's premises during pendency of the Complaint and the matter was admitted to the extent of initiation of proceedings.

The Respondent Board is directed to submit reply on or before 12/02/2025 with a copy of reply to the Complainant and rejoinder if any, may be submitted by the Complainant immediately thereafter the submission of the reply by the Respondent Board. The arguments may be conducted on 25/02/2025 subject to the submission of above documents and mutual consensus of both the parties. **The concerned Assistant Engineer is directed to appear in the court room along with the relevant record to avoid any misconception during the course of deliberations /arguments and to facilitate counsel thereof. Any lapse shall attract onus on individual.**

Accordingly, the case is listed for final arguments on dated 25/02/2025 at 12:00 PM. or Immediately thereafter subject to submission of above documents. The order is also placed at site as well as conveyed telephonically for the convenience of concerned.
