## PUBLIC NOTICE INVITING SUGGESTIONS/OBJECTIONS In the matter of

## Petition No. 2 of 2020

The Himachal Pradesh Power Transmission Corporation Limited (hereinafter referred to as the "the HPPTCL") has filed a petition for approval of Capital cost and determination of tariff for the period 05.06.2016 (COD) to FY2023-24 for 30/220kV, 80/100MVA GIS Sub- Station Phojal along with 220kV D/C LILO Transmission Line before the Himachal Pradesh Electricity Regulatory Commission (hereinafter referred to as "the Commission" or "the HPERC") under section 62 read with section 86 of the Electricity Act, 2003 (Act No. 36 of 2003) and regulation 12(1) of HPERC (Terms and Conditions for determination of Transmission Tariff) Regulations, 2011 and subsequent amendments to the tariff regulations carried thereafter. The salient features of the petition were published by the HPPTCL in the newspapers i.e. "The Tribune" on 13.02.2020 and in "Amar Ujala" on 14.02.2020.

As required under Section 64(3) of the Electricity Act, 2003, the HPERC hereby invites suggestions and objections in the matter from the interested parties. Suggestions/objections on the issues together with relevant data, details and copies of documents, if any, in support of the suggestions/objections, be sent to the Secretary, Himachal Pradesh Electricity Regulatory Commission, Vidyut Aayog Bhawan, Block No. 37, SDA Complex, Kasumpti, Shimla-171009 alongwith proof of service of the same to the Deputy General Manager (C&M), HPPTCL, Himfed Bhawan, Panjari, Shimla-171005 by 9<sup>th</sup> March, 2020.

The suggestions / objections shall be filed in English or Hindi. Suggestions / objections filed in any other language shall not be accepted unless accompanied by authenticated translation in English. The suggestions/objections should be filed in nine copies and should carry the full name, postal address with pin code number, fax number and email address, if any, of the person sending the suggestions/objections. Alternatively the suggestions/ objections can also be filed through email to the Commission and HPPTCL (<a href="mailto:dgmcomm@hpptcl.in">dgmcomm@hpptcl.in</a>) along with 2 hard copies to the Commission. It should be indicated whether the objection is being filed on behalf of any organization or any category of consumers. It should also be stated whether the objector wants to be heard in person by the Commission.

The HPPTCL shall submit replies to the suggestions/objections on affidavit with 9 copies to the Commission by 17<sup>th</sup> March, 2020, one copy of which shall also be sent to the individual objectors. The objectors shall submit rejoinder, if any, to the Commission with a copy to the petitioner, HPPTCL by 25<sup>th</sup> March, 2020.

The public hearing in the matter shall be held on 27<sup>th</sup> March, 2020 at 11.30 A.M. or immediately afterwards in the Commission's Court Room at Shimla, wherein the Objectors can present their cases in the proposed hearing. Stakeholders in general, may also participate in the hearing.
