No. HPERC/151/Vol-III.—In exercise of the powers conferred by subsection (1) of section 92 and clause (zl) of sub-section (2) of section 181 of the Electricity Act, 2003(36 of 2003), read with section 21 of the General Clauses Act, 1897(10 of 1897), and all other powers enabling it in this behalf as contained in the Electricity Act, 2003 and any other law for the present being in force, the Himachal Pradesh Electricity Regulatory Commission proposes to make the following draft regulations further to amend the Himachal Pradesh Electricity Regulatory Commission (Conduct of Business) Regulations, 2005, published in the Rajpatra, Himachal Pradesh (Extraordinary), dated 14th January, 2005 and as required by sub-section (3) of section 181 of the said Act and rule 3 of the Electricity (Procedure for Previous Publication) Rules, 2005, the said draft regulations are hereby published for the information of all the persons likely to be affected thereby; and notice is hereby given that the said draft regulations will be taken into consideration, after the expiry of thirty days from the date of their publication in the Rajpatra, Himachal Pradesh, together with any objections or suggestions which may within the aforesaid period be received in respect thereto.

## DRAFT REGULATIONS

- 1. **Short title and commencement.—(1)** These regulations may be called the Himachal Pradesh Electricity Regulatory Commission (Conduct of Business) (Twelfth Amendment) Regulations, 2022.
  - (2) These regulations shall come into force from the date of their publication in the Rajpatra, Himachal Pradesh.

- 2. **Amendment of the Schedule.** In the Schedule i.e. "Fee Structure" annexed to the Himachal Pradesh Electricity Regulatory Commission (Conduct of Business) Regulations, 2005—
