HIMACHAL PRADESH ELECTRICITY REGULATORY COMMISSION, SHIMLA NOTIFICATION

No. HPERC/418.- In exercise of the powers conferred under sub-section (2) of section 181, read with sections 30, 32, 39, 40, 42 and 86, of the Electricity Act, 2003 (36 of 2003), and all other powers enabling it in this behalf, the Himachal Pradesh Electricity Regulatory Commission, after previous publication, hereby makes the following regulations to further amend the Himachal Pradesh Electricity Regulatory Commission (Grant of Connectivity, Long-term and Medium-term intra-State Open Access and Related Matters) Regulations, 2010, read with first and second amendment thereof as per the notification issued on 07.12.2012 and 11.08.2021 and published in the Rajpatra, Himachal Pradesh on 10.12.2012 and 16.08.2021 respectively (hereinafter jointly referred to as "the said regulations"), namely :-

REGULATIONS

1. **Short title and commencement**.- (1) These regulations may be called the Himachal Pradesh Electricity Regulatory Commission (Grant of Connectivity, Long-term and Medium-term intra-State Open Access and Related Matters) (Third Amendment) Regulations, 2024.

(2) These regulations shall come into force from the date of their publication in the Rajpatra, Himachal Pradesh.

2. **Amendment of Regulation 6.-** In Regulation 6 of the Himachal Pradesh Electricity Regulatory Commission (Grant of Connectivity, Long-Term Intra-State Open Access and Related Matters) Regulations, 2010 (hereinafter referred to as "the said Regulations"), for the existing table the following table shall be substituted, namely:-
