PUBLIC NOTICE INVITING SUGGESTIONS/OBJECTIONS

In the matter of

Petition No. 41 of 2023

The Himachal Pradesh Power Transmission Corporation Limited (hereinafter referred to as the "the HPPTCL") has filed a present Petition for approval of Capital Cost and Determination of Tariff for 4th Control Period from COD to FY 2023-24 for 220 kV D/C Snail-Hatkoti Transmission Line, under Section 62 read with Section 86 of the Electricity Act, 2003 and the Himachal Pradesh Electricity Regulatory Commission (Terms and Conditions for determination of Transmission Tariff) Regulations, 2011 as amended from time to time. The salient features of the Petition were published by the HPPTCL in the newspapers i.e. "The Indian Express" and "Amar Ujala" on 28th July, 2023.

As required under Section 64(3) of the Electricity Act, 2003, the Himachal Pradesh Electricity Regulatory Commission hereby invites suggestions and objections in the matter from the interested parties. Suggestions/objections on the issues together with relevant data, details and copies of documents, if any, in support of the suggestions/objections, be sent to the **Secretary, Himachal Pradesh Electricity Regulatory Commission, Vidyut Aayog Bhawan, Block No. 37, SDA Complex, Kasumpti, Shimla-171009** alongwith proof of service of the same to the **Deputy General Manager (C&M), HPPTCL, Himfed Bhawan, Panjiri, Shimla-171005** by **05th September, 2023**.

The suggestions / objections shall be filed in English or Hindi. The suggestions/objections should be filed in nine copies and should carry the full name, postal address with pin code number, fax number and email address, if any, of the person sending the suggestions/objections. Alternatively, the suggestions/ objections can also be filed through email to the Commission (secy-hperc@hp.gov.in) and the HPPTCL (dgmcomm@hpptcl.in) along with 3 hard copies to the Commission and to HPPTCL.

The HPPTCL shall submit replies to the suggestions/objections on affidavit with 9 copies to the Himachal Pradesh Electricity Regulatory Commission by **12th September, 2023**, one copy of which shall also be sent to the individual objectors in hard copy as well as through email. The objectors shall submit rejoinder, if any, to the Commission with advance copy to the Petitioner, HPPTCL by **18th September, 2023**.

The public hearing in the matter shall be held on **20th September, 2023** immediately after the public hearing relating to True up and Mid Term Performance Review for Generation Business of HPSEBL (Petition No. 40/2023) scheduled on the same date i.e. 20th September, 2023 at 11:00 AM onwards in the Commission at Shimla, wherein the Objectors can present their cases. Stakeholders in general, may also participate in the Public hearing.
