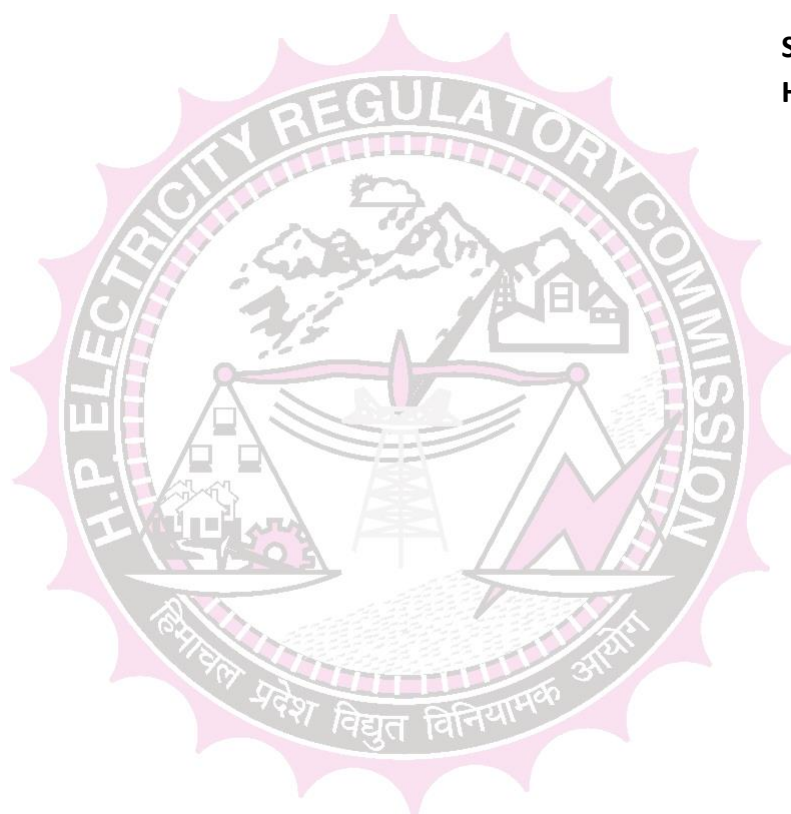
As required under Section 64(3) of the Electricity Act, 2003, the Himachal Pradesh Electricity Regulatory Commission hereby invites suggestions and objections in the matter from the interested parties. Suggestions/objections on the issues together with relevant data, details and copies of documents, if any, in support of the suggestions/objections, be sent to the **Secretary, Himachal Pradesh Electricity Regulatory Commission, Vidyut Aayog Bhawan, Block No. 37, SDA Complex, Kasumpti, Shimla-171009** along with proof of service of the same to the **M/s JSW Hydro Energy Limited, Karcham Wangtoo H.E. Project, Sholtu, P.O. Tapri, Distt. Kinnaur (H.P.)-172104** by **20th March, 2024**.

The suggestions / objections shall be filed in English or Hindi. The suggestions/objections should be filed in nine copies and should carry the full name, postal address with pin code number, fax number and email address, if any, of the person sending the suggestions/objections. Alternatively, the suggestions/ objections can also be filed through email to the Commission (secy-hperc@hp.gov.in) and the M/s JSWHEL (agarwal.anurag@jsw.in, kanwar.bhanu@jsw.in) along with 3 hard copies to the Commission and to M/s JSWHEL.

M/s JSWHEL shall submit replies to the suggestions/objections on affidavit with 9 copies to the Himachal Pradesh Electricity Regulatory Commission by **20th March, 2024**, one copy of which shall also be sent to the individual objectors in hard copy as well as through email. The objectors shall submit rejoinder, if any, to the Commission with advance copy to the Petitioner, M/s JSWHEL by **21st March, 2024**.

The public hearing in the matter shall be held on **23rd March, 2024** at **12:30 PM** onwards after the public hearing in Petition No. 22/2024 scheduled at 11:00 AM on 23rd March, 2024 in the Commission at Shimla, wherein the Objectors can present their cases. Stakeholders in general, may also participate in the Public hearing.
