PUBLIC NOTICE INVITING SUGGESTIONS/OBJECTIONS In the matter of

Petition No. 117 of 2024

The Himachal Pradesh State Electricity Board Limited (hereinafter referred to as the "HPSEBL") has filed a Petition for Annual Revenue Requirement for 5th MYT Control Period FY 2024- 25 to FY 2028-29 for Generation Business of 13 Nos. of Hydro Generation Plants, under Section 62 read with Section 86 of the Electricity Act, 2003 and the Himachal Pradesh Electricity Regulatory Commission (Terms and Conditions for Determination of Generation Tariff) Regulation, 2011 as amended from time to time. The salient features of the Petition were published by HPSEBL in the newspapers i.e. **"The Tribune"** and **"Divya Himachal"** on **22nd September, 2024** and in **"Hindustan Times"** and **"Punjab Kesari"** on **23rd September, 2024**.

As required under Section 64(3) of the Electricity Act, 2003, the Himachal Pradesh Electricity Regulatory Commission hereby invites suggestions and objections in the matter from the interested parties. Suggestions/objections on the issues together with relevant data, details and copies of documents, if any, in support of the suggestions/objections, be sent to the Secretary, Himachal Pradesh Electricity Regulatory Commission, Vidyut Aayog Bhawan, Block No. 37, SDA Complex, Kasumpati, Shimla-171009 alongwith proof of service of the same to the Executive Director (Personnal) Hpsebl, Vidyut Bhawan, Shimla -171004 by 04th November, 2024.

The suggestions / objections shall be filed in English or Hindi. The suggestions/objections should be filed in nine copies and should carry the full name, postal address with pin code number, fax number and email address, if any, of the person sending the suggestions/objections. Alternatively the suggestions/ objections can also be filed through email to the Commission (secy-hperc@hp.gov.in) and HPSEBL (cecomm@hpseb.in and edp@hpseb.in) along with 3 hard copies to the Commission and to HPSEBL.

The HPSEBL shall submit replies to the suggestions/objections on affidavit with 9 copies to the HPERC by **11th November, 2024**. One copy of which shall also be sent to the individual objectors in hard copy as well as through email. The objectors shall submit rejoinder, if any, to the Commission with advance copy to the Petitioner, HPSEBL by **16th November, 2024**.

The public hearing in the matter shall be held on **20th November, 2024** at **11:00 AM** onwards in the Commission at Shimla, wherein the Objectors can present their cases. Stakeholders in general, may also participate in the Public hearing.
