The Himachal Pradesh State Load Despatch Centre (hereinafter referred to as the "the HPSLDC") has filed the petition for approval of True-up for FY 2020-21 to FY 2022-23, Provisional True-up for FY 2023-24, Business Plan and Aggregate Revenue Requirement(ARR) for 5th MYT Control Period from FY 2024-25 to FY 2028-29 on 7 December 2023. The HPSLDC has submitted further details through MA No.13/2024 dated 20.01.2024 before the HPERC. As required under section 64(3) of the Electricity Act, 2003, the HPERC hereby invites suggestions and objections in the matter from the interested parties. Suggestions/objections on the issues together with relevant data, details and copies of documents, if any, in support of the suggestions/objections, be sent to the Secretary, Himachal Pradesh Electricity Regulatory Commission, Vidyut Aayog Bhawan, Block No. 37, SDA Complex, Kasumpti, Shimla-171009 along with proof of service of the same to the Superintending Engineer, HPSLDC, Govt. of HP, Totu, Shimla-11 by 5 March, 2024. The suggestions/objections shall be filed in English or Hindi. The suggestions/objections should be filed in two copies and should carry the full name, postal address with pin code number, fax number, email address, if any, of the person sending the suggestions/objections. Alternatively the suggestions/objections can also be filed through email to the Commission (secy-hperc@hp.gov.in) and HPSLDC (sehpsldc@gmail.com) along with 2 hard copies to the Commission.

The HPSLDC shall submit replies to the suggestions/objections on affidavit with 9 copies to the Commission by **08.03.2024**. One hard copy and one soft copy through e mail shall also be sent

to the individual objectors. The objectors shall submit rejoinder, if any, to the Commission with a copy to the HPSLDC by **10.03.2024**.

The public hearing in the matter shall be held on <u>13.03.2024</u> at 11.30 A.M. onwards in the Commission at Shimla, wherein the stakeholders can present their comments in the hearing. Stakeholders in general, may also participate in the hearing.
