PUBLIC NOTICE INVITING SUGGESTIONS/OBJECTIONS In the matter of

Petition No. 116 of 2024

The Himachal Pradesh Power Transmission Corporation Limited (hereinafter referred to as the "the HPPTCL") has filed a present Petition for approval of Capital Cost and determination of Tariff for 4th Control Period from COD to FY 2023-24 for 66/22 kV Substation Nirmand (Bagipul)- (Asset-I) & 66 kV D/C Nirmand - Kotla Transmission Line- (Asset-2), under Section 62 read with Section 86 of the Electricity Act, 2003 and the Himachal Pradesh Electricity Regulatory Commission (Terms and Conditions for Determination of Transmission Tariff) Regulations, 2011 as amended from time to time. The salient features of the Petition were published by the HPPTCL in the newspapers i.e. "Amar Ujala" and "The Tribune" on 10th August, 2024.

The full text of the Petition under consideration can be obtained from the office of the General Manager, HPPTCL on payment of Rs. 1500/- w.e.f. 11th August, 2024. Interested parties are also free to see, examine and inspect the detailed compilation at the above mentioned office of HPPTCL during office hours on any working day. As required under Section 64(3) of the Electricity Act, 2003, the HPERC hereby invites suggestions and objections in the matter from the interested parties. Suggestions/objections on the issues together with relevant data, details and copies of documents, if any, in support of the suggestions/objections, be sent to the Secretary, Himachal Pradesh Electricity Regulatory Commission, Vidyut Aayog Bhawan, Block No. 37, SDA Complex, Kasumpati, Shimla-171009 alongwith proof of service of the same to the Deputy General Manager (C&M), HPPTCL, Himfed Bhawan, Panjiri, Shimla-171005 by 21st September, 2024.

The suggestions / objections shall be filed in English or Hindi. The suggestions/objections should be filed in nine copies and should carry the full name, postal address with pin code number, fax number and email address, if any, of the person sending the suggestions/objections. Alternatively the suggestions/ objections can also be filed through email to the Commission (secy-hperc@hp.gov.in) and the HPPTCL (dgmcomm@hpptcl.in) along with 3 hard copies to the Commission and to HPPTCL.

The HPPTCL shall submit replies to the suggestions/objections on affidavit with 9 copies to the HPERC by **28**th **September, 2024,** one copy of which shall also be sent to the individual objectors in hard copy as well as through email. The objectors shall submit rejoinder, if any, to the Commission with advance copy to the Petitioner, HPPTCL by **03**rd **October, 2024.**

The public hearing in the matter shall be held on **05**th **October, 2024** at 11:30 AM onwards in the Commission at Shimla, wherein the Objectors can present their cases. Stakeholders in general, may also participate in the Public hearing.
