**PUBLIC NOTICE INVITING SUGGESTIONS/OBJECTIONS**

M/s JSW Hydro Energy Limited (hereinafter referred to as the "JSWHEL") has filed a petition for Truing up of Tariff for FY 2019-20 to FY 2021-22 and Mid Term Review for FY 2022-23 & FY 2023-24 for sale of power from Baspa-II HEP to the Himachal Pradesh State Electricity Board Limited (hereinafter referred to as the "HPSEBL") under Section 62 read with Section 86 of the Electricity Act, 2003 and the Himachal Pradesh Electricity Regulatory Commission (Terms and Conditions for Determination of Generation Tariff) Regulation, 2011 as amended from time to time. The salient features of the petition were published by M/s JSWHEL in the newspapers i.e. "Dainik Bhaskar" and "The Tribune" on 15<sup>th</sup> Jaunary, 2023 and in "Dainik Bhaskar" and "The Tribune" on 16<sup>th</sup> Jaunary, 2023.

As required under Section 64(3) of the Electricity Act, 2003, the HPERC hereby invites suggestions and objections in the matter from the interested parties. Suggestions/objections on the issues together with relevant data, details and copies of documents, if any, in support of the suggestions/objections, be sent to the **Secretary, Himachal Pradesh Electricity Regulatory Commission, Vidyut Aayog Bhawan, Block No. 37, SDA Complex, Kasumpti, Shimla-171009** alongwith proof of service of the same to the M/s JSW Hydro Energy Limited, Karcham Wangtoo H.E. Project, Sholtu, P.O. Tapri, Distt. Kinnaur (H.P.)- 172104 by **21<sup>st</sup> February 2023**.

The suggestions / objections shall be filed in English or Hindi. The suggestions/objections should be filed in nine copies and should carry the full name, postal address with pin code number, fax number and email address, if any, of the person sending the suggestions/objections. M/s JSWHEL shall submit replies to the suggestions/objections on affidavit with 9 copies to the HPERC by **25<sup>th</sup> February, 2023**. One copy of which shall also be sent to the individual objectors in hard copy as well as through email. The objectors shall submit rejoinder, if any, to the Commission with advance copy to the petitioner, M/s JSWHEL by **01<sup>st</sup> March, 2023**.

The public hearing in the matter shall be held on **04<sup>th</sup> March, 2023** immediately after the public hearing relating to Retail Tariff (Petition No. 01/2023) scheduled on the same date i.e. 04<sup>th</sup> March, 2023 at 11:00 AM onwards in the Commission at Shimla, wherein the Objectors can present their cases. Stakeholders in general, may also participate in the Public hearing.
