1. The Chairman of the Electricity Supply Code Review Panel shall hold office as such for a period of two years and its all other member shall hold office by the virtue of positions held by them in their respective organisation until changed/replaced by the respective organisation/consumer group.
2. A member of the Electricity Supply Code Review Panel, who is a Govt. officer or an employee/officer of any Govt. instrumentality or of any Public Sector undertaking, shall draw travelling and daily allowance from his parent department or organization.
3. A member of Electricity Supply Code review Panel, other than those referred to under sub-para(2) shall be paid fee of Rs.500/- per meeting and TA and DA at the rates admissible, in the State Govt. to its grade-I officers.
