INVITATION OF APPLICATIONS FOR THE NOMINATION OF INDEPENDENT MEMBER

The Himachal Pradesh Electricity Regulatory Commission (HPERC) invites applications from suitable persons for the nomination of Independent Member in the Consumer Grievances Redressal Forum (CGRF) for Consumers of the Himachal Pradesh State Electricity Board Limited (HPSEBL) at Shimla to discharge various functions relating to Redressal of Consumers Grievances against Distribution Licensee (HPSEBL) as per the provisions of the (Consumers Redressal Forum and Ombudsman) Regulations, 2013 and its amendments thereof.

The qualifications, terms & conditions of appointment of the independent member shall be as provided in the HPERC (Consumer Grievances Redressal Forum and Ombudsman) Regulations, 2013 and the HPERC order (Salary and other allowances of the Nominated Independent Member of the consumers Grievances Redressal forum) order 2022, which are available on the Commissions website:[https:// www.hperc.org](https://www.hperc.org).

The brief details are as given below:

Eligibility:

- (a) “who are retired officers of the Centre or State Government or its Undertakings having minimum service experience of ten years as such and are familiar with the consumer affairs, power sector or regulatory affairs; or”.
- (b) who are representatives of the registered voluntary consumers protection organisations or NGOs or consumer activities with experience of at least five years in dealing with matter.

Provided that a person to be nominated as Independent Member of the Forum shall not have been in the employment in any capacity under, or agency of, the licensee; for a minimum period of one year prior to his being nominated as the Independent Member of the Forum.

***Remuneration:** Honorarium: Rs.25,000/- and conveyance allowance Rs.6,000/- per month. TA/DA: As admissible to Grade-I Officer of HPSEBL.

Interested persons may send their application, bio-data, and a write-up (max. 100 words) on suitability for nomination to the Secretary, HPERC, Vidyut Aayog Bhawan, Block-37, SDA Complex, Kasumpti, Shimla-171009, on or before 23.03.2026.
