Joint Petition under the provisions of Section 86(1)(b) of the Electricity Act 2003 read with Regulations 56 and 57 of the HPERC (Conduct of Business) Regulations, 2024, for the approval of the Power Purchase Agreement (Solar) in respect of Intelle Sun Power Pvt. Ltd. Solar Power Project (5.0 MW).

ORDER

This Joint Petition has been filed by the Himachal Pradesh State Electricity Board Ltd. (the Joint Petitioner No.1 or the HPSEBL for short) and Intelle Sun Power Pvt. Ltd. Solar Power Project (the Joint Petitioner

No. 2 for short) for the approval of the Power Purchase Agreement (PPA for short) under section 86 (1) (b) of the Electricity Act, 2003 (Act for short) read with Regulations 56 and 57 of the Himachal Pradesh Electricity Regulatory Commission (Conduct of Business) Regulations, 2024, (CBR, 2024 for short) in respect of Intelle Sun Power Pvt. Ltd. Solar Power Project (5.0 MW) proposed to be set up at Village and Post Office Sera, Tehsil Nadaun, Distt. Hamirpur, H.P.

2. As per the Petition, the HIMURJA, vide letter No. HIMURJA(F-7)/SPV Projects/2024-14187 dated 27.03.2026, has accorded 'in principle' approval for setting up of the Intelle Sun Power Pvt. Ltd. Solar Power Project under the scheme "Allotment and Registration of Solar Power Projects range from 250 kW – 5MW – Open Policy" subject to certain conditions specified therein. The Scheduled Commercial Operation Date (SCOD) of the Project is 26.03.2027. Further, as per the affidavit of the Joint Petitioner No. 2 filed with the Petition, the proposed location of the Project falls in rural area.

3. Heard. Sh. Rajesh Kashyap, Ld. Counsel for the Joint Petitioner No. 1 and Sh. Rohit Mittal, Authorised Representative for the Joint Petitioner No. 2 and have perused the entire record carefully.

4. It is evident from the record that the connection agreement in respect of the Project has been signed by the Joint Petitioners on

23.07.2026, a copy whereof has been placed on record. As per the connection agreement, the Interconnection Point of the project has been provided at Proposed 33 kV bay at 132/33/11 kV Nadaun (Gaggal) Sub-station (Transformation level at 132/33 kV is 1x25/31.5 MVA) with appropriate protection arrangement. As per the connection agreement, M/s Intelle Sun Power Pvt. Ltd. Solar Power Project (5.0 MW) shall evacuate its power in joint mode with M/s Suryavidya Energies Pvt. Ltd. Solar Power Project (5.0 MW). The Joint Petitioners have placed on record the Joint Evacuation Agreement dated 23.07.2026 signed between Intelle Sun Power Pvt. Ltd. Solar Power Project (5.0 MW) and Suryavidya Energies Pvt. Ltd. Solar Power Project (5.0 MW) that they have agreed not to claim any damages or losses, if any, occurring out of the said joint evacuation arrangement in future which shall form part of the PPA.

5. The Government of Himachal Pradesh vide notification No. MPP-F(10)-43/2023 dated 21st September, 2023 amending clause 4.3.11 of the Swaran Jayanti Energy Policy, 2021 has levied a tariff based royalty of 5 paise per unit on commissioning Solar Power Project having capacity of more than 1 MW. Since, this provision has come into being w.e.f 21.09.2023, the tariff based royalty has to be paid in the manner provided in the policy to the State Government. Accordingly, the royalty

as provided i.e. 5 paise per unit shall be worked out by the HPSEBL from the generation of the project and shall be payable @ 5 paise per unit to the Government of HP over and above the approved tariff of the project which shall be eligible for the pass through.

6. The Commission, after careful examination of the entire record of the case and the averments made in the petition, is satisfied that Joint Petitioners have made out a case for approval of the Power Purchase Agreement (Solar) in respect of the Project. Therefore, the Commission, in exercise of the powers conferred by section 86 (1)(b) of the Act read with Regulations 56 and 57 of the CBR, 2024, accord its approval to the said Power Purchase Agreement subject to the following conditions:-

- (i) The tariff of Rs. 3.34 per kWh shall be applicable to the Project of the Joint Petitioner No. 2 subject to the adjustment of admissible subsidy, if any, in accordance with the conditions stipulated in the Commission's Order dated 31.03.2026 passed in Suo Moto Petition No. 14 of 2026.
- (ii) The Joint Petitioner No. 2 shall make an endeavour to avail admissible subsidy/financial assistance, if any, and shall intimate the Joint Petitioner No. 1 of any subsidy/financial assistance received from the State/Central Government or its designated Department(s)/agency(ies) within 15 days from the date of receipt of such subsidy/financial assistance, for tariff adjustment by Joint petitioner No. 1. An undertaking to this effect shall form part of the PPA. In the event that the admissible subsidy/financial assistance is not availed, or the Joint Petitioner No. 2 fails to approach the State/Central Government or its designated Department(s)/Agency(ies) for the same, such subsidy/financial assistance shall be

deemed to have been availed by the Joint Petitioner No. 2 for the purpose of tariff adjustment by the Joint Petitioner No. 1.

- (iii) The affidavit of the Joint Petitioner No. 2 that the Project is in the rural area and the Connection Agreement dated 23.07.2026 and Joint Evacuation Agreement dated 23.07.2026, shall form part of the PPA.
- (iv) In case there is enhancement in tariff for the FY 2027-28, such enhancement shall not be applicable for the Project. However, in case the tariff during the FY 2027-28 is less than the tariff determined vide Order dated 31.03.2026 in Suo Moto Petition No. 14 of 2026, such reduced tariff shall be applicable after 31.03.2028.
- (v) The royalty as provided i.e. 5 paise per unit shall be worked out by the HPSEBL from the generation of the project and shall be payable @ 5 paise per unit to the Government of HP over and above the approved tariff of the project which shall be eligible for the pass through.

7. Other terms and conditions of the PPA shall be subject to the provisions of the Himachal Pradesh Electricity Regulatory Commission (Promotion of Generation from the Renewable Energy Sources and Terms and Conditions for Tariff Determination) Regulations, 2017, as amended from time to time, and the Order of the Commission passed on 31.03.2026 in Suo-Motu Petition No. 14 of 2026 under the said Regulations.

8. The Joint Petitioners are directed to execute PPA as per the above Order after carrying out the necessary additions and alterations within 30

days from the date of this Order. Three copies of the executed Power Purchase Agreement be submitted to the Commission for record.

9. Let a copy of this Order be supplied to the Joint Petitioners forthwith.
